## APPENDIX 2: ELIGIBILITY CRITERIA

### *Who does the Northampton Saints Benevolent Fund support?*

- Any past player who has represented the Northampton Saints 1st XV.
- Any current player (including any contracted Academy player) who has had a contract of employment with Northampton Saints Rugby Football Club for at least 12 months.
- Any current or past member of staff of Northampton Saints Rugby Football Club or the Northampton Saints Foundation who has worked for the Club/Foundation for at least 12 months.

- A dependant of any of the above. In this context, a dependant is defined as a partner or spouse,

children including adopted/fostered/step or for those whom the applicant has parental responsibility or guardianship.

- Other individuals with a close working connection with the Club as determined on a case-by-case

basis.

### ***What does the Northampton Saints Benevolent Fund provide?***

- Support in times of need, including but not limited to injury, illness, disability, bereavement.
- Specifically, the fund can offer:

o Signposting to other organisations that may be able to offer support

### **APPENDIX 3: HOW/WHEN WILL THE BENEVOLENT FUND COMMITTEE MAKE DECISIONS?**

- The nature and level of support shall be determined by Northampton Saints Benevolent Fund committee acting in its sole discretion, and will be based on a range of factors including (but not limited to) the nature of the issue, the role support could potentially play, and the role and tenure of the individual at the Club.
- Financial grants will only be awarded where there is unanimous agreement from all the Northampton Saints Benevolent Fund committee that support should be given.
- The Northampton Saints Benevolent Fund committee will review applications for support and will notify the individual requesting support of its decision within four weeks of an application being received.
- The decisions of the Northampton Saints Benevolent Fund committee shall be final and are not open to appeal.
